# What is Title I?



**Title I is part of a federal law that grants money to select schools to:**

- Help meet students' educational needs and goals,
- Provide staff with professional development, and
- Support school and family partnerships.



# How does a school become Title I?



- **Eligibility for 2024-2025 School Year**
- District sets Free and Reduced Priced Lunch (FRPL) percent threshold:
  - 70% for elementary, middle and combination schools
  - 67% for high schools



# What does it mean for our School?

- Additional funds to support students, teachers, and families!
  - These funds are over and above what the District provides.
  - Funds concentrated in instruction for students, professional development for our teachers, and activities to strengthen our partnership with families.

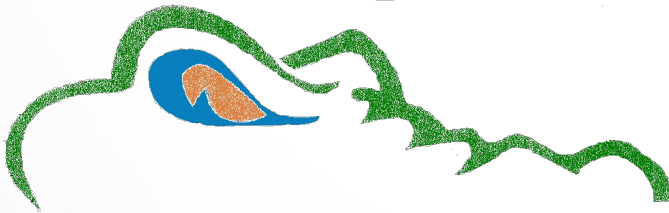


# Title I Focus

PBGHS is always committed to involving families in shared decision-making and encouraging families to become active participants in their child's educational process by effectively communicating instructional goals, creating an inviting environment for families, and establishing the school as the center of the community.

**Annual Title I Meeting**

Each year, at the beginning of the school year, families are invited to attend the Annual Title I Meeting to learn more about our schoolwide Title I Program and the requirements of Title I. Our meeting will be held on Tuesday, September 10, 2024, @ 5:30 PM in the Media Center.

**Parent and Family Engagement Activities**

Based on family survey input, we will provide the following activities to assist families in understanding the state curriculum and assessments to help families improve their student's academic achievement:

- **Keys to Success** – Families will learn how to monitor student grades and access tutorial resources as well as attendance and tardies. Families will learn about the core content taught (Math, Science, Literacy) and state standards. Families will learn what assessments are required for graduation and how to support student success on these assessments. This meeting will be held in October 2024.
- **Pathway to Success** – Families will be able to access career research tools available through PBCSD and learn about postsecondary opportunities. Families will review goals for their students to accomplish by the end of each year of high school. Families will also explore different financial aid options available for their students. They will access SIS Gateway to monitor their student's academic success and learn about the scholarship opportunities available. This meeting will be held in November 2024 @ 6:00 PM in the Media Center.
- **Parent University** – Parents will learn about credit requirements for graduation and options for Advanced Placement, AICE, and Dual Enrollment courses to help their students navigate a rigorous course load and be university-ready. This meeting will be held in January 2025.
- **Parent callouts** and the PBGHS Website will always provide updated information on Parent Engagement Activities

**Shared Decision Making**

Families will be invited to many meetings throughout the year to receive academic information and provide input on ways the school, families, and students can share responsibility for student success. This information will create the school's Parent and Family Engagement Plan (PFEP) and School-Parent

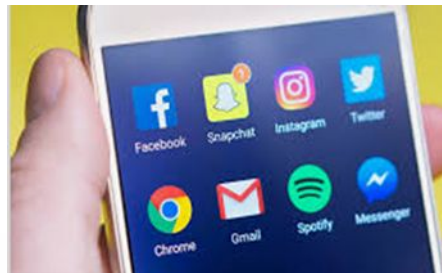

# Parents' Right to Know

Families have the right to ask:

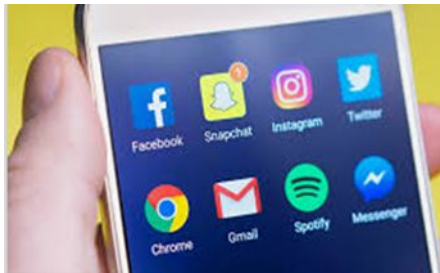
- About the professional qualifications of their child's teachers; and
- If non-teacher personnel are providing instruction to their child and, if so, their professional qualifications.



# Parents' Right to Know

Families must be informed:

- If their child is taught for four or more weeks by a teacher who does not meet the certification requirements for the grade level or subject being taught; and
- How their child performed on state tests like FSA, EOCs, and SSA.





# Migrant Education Program



Ensure the needs of migrant students are met to help them overcome:

- Breaks in schooling
- Cultural and language barriers
- Social isolation
- Health-related problems
- Transition to college or work after high school

To improve educational opportunities of migrant students by helping them:

- Succeed in the regular school program
- Achieve grade level academic standards
- Meet the challenging state academic content
- Graduate from high school



# Students Experiencing Homelessness

## Every Student Has the Right to an Education

The McKinney-Vento Homeless Education Program (MVP) Team can help families who live:

- In a shelter, motel, vehicle, or campground;
- On the street;
- In abandoned buildings or substandard housing;
- In motels/hotels; or
- Doubled-up temporarily with relatives or friends due to a hardship



# Students Experiencing Homelessness

Every school has a McKinney-Vento Contact Person & assigned McKinney-Vento Homeless Education Program (MVP) Case Manager who works with families to:

- Provide school supplies, uniforms, supplemental services and free school meals;
- Set up transportation to and from the school of origin;
- Find community support and resources;
- Decide which school would be best for the child;
- Communicate with the school;
