Bus Conduct & Transportation



Bus Transportation for students living more than two miles from school is governed by the state and provided by the county. For further information, call the transportation parent call center at 561.242.6505 or website: palmbeachschools.org/transportation/

A student is subject to the authority and discipline of the bus driver AT ALL TIMES. School bus misconduct or vandalism is reported by the bus driver to the school administrators on a referral form. Any student receiving a bus referral will have a consequence with their assistant principal. Riding the bus is a privilege. A student may be suspended from riding the bus if his/her conduct presents a safety concern.

The principal or designee may suspend any student transported to and from school from the privilege of riding a school bus for a period not to exceed ten consecutive school days or until such suspension is modified or made and expulsion by the School Board. Students and parents will be notified within 24 hours.

Teacher's Response

- Make parent contact (keep a log) & assign two detentions. If unserved, see step #4
- 4. Make a referral to administration.
