# Domain 2, 3 & 4 Clarifications

Please be advised that Domains 2, 3 and 4 are <u>NOT optional</u>; therefore, the elements are <u>rated when applicable</u> (in FY15 Domain 4 is only rated at the request of the teacher). A chart detailing when elements within each domain may be rated is attached.

Please note that it is very common for elements within Domain 2 and Elements 50-52 in Domain 3 to be rated as a result of conversations had during pre- and post-observation conferences; however, these elements may be rated in other instances when they are dominant (see chart on following page for specifics).

Also note that elements 53 and 54 within Domain 3 may be scored even if teachers did not complete an individualized Professional Growth Plan as long as they are participating in and implementing new learning from school-based professional development opportunities. If either of these elements are rated as Developing, a conversation should be conducted with the teacher.

# Data Mark Update

As a result of the updated FY15 Observation Schedule (see page 3 for schedule) for Category 1B and 2 Teachers, the JENC Committee has come to a consensus that the required number of data marks required to process the final evaluation for Category 1B and 2 teachers will decrease. The new range is 10-20+ data marks. The requirement for 15+ data marks to process each evaluation for 1As has not changed.

## **FY15 Final Evaluation Updates**

Per F.S. 1012.34, in FY15 adjustments are required to be made to the components of the final evaluation.

- <u>Adjustment 1:</u> If a teacher had an individual VAM score provided from the state for the past three years, their final evaluation rating must consist of 50% student growth.
- <u>Adjustment 2:</u> In previous years the final evaluation rating was comprised of student growth and instructional practice. According to F.S. 1012.34, a third component is now required. The third component negotiated by the JENC Committee is titled Professional Growth.
  - Your final evaluation rating will include the new Professional Growth component, which will be 2% of your total final rating.
  - All teachers will receive the rating of "Highly Effective" for this component of the evaluation if they complete the Course Evaluation Survey for their school -based professional development in eLearning. (The survey can be accessed under the following course in eLearning: 2007010 FY14 (SCHOOL NAME) 11/4-2/26.)


