Cluster 1: Text Types and Purposes

- a. Introduce a topic or text clearly, state an opinion, and create an organizational structure in which related ideas are grouped to support the writer's purpose.
- b. Provide reasons that are supported by facts and details.
- C. Link opinion and reasons using words and phrases (e.g., for instance, in order to, in addition).
- d. Provide a concluding statement or section related to the opinion presented.

LAFS.4.W.1.2 Write informative/explanatory texts to examine a topic and convey ideas and information clearly. (CCL2)

- a. Introduce a topic clearly and group related information in paragraphs and sections; include formatting (e.g., headings), illustrations, and multimedia when useful to aiding comprehension.
- b. Develop the topic with facts, definitions, concrete details, quotations, or other information and examples related to the topic.
- c. Link ideas within categories of information using words and phrases (e.g., another, for example, also, because).
- d. Use precise language and domain-specific vocabulary to inform about or explain the topic.

- a. Orient the reader by establishing a situation and introducing a narrator and/or characters; organize an event sequence that unfolds naturally.

- c. Use a variety of transitional words and phrases to manage the sequence of events.
- d. Use concrete words and phrases and sensory details to convey experiences and events precisely.
- e. Provide a conclusion that follows from the narrated experiences or events.

Strand: Language

Cluster 1: Conventions of Standard English

LAFS.4.L.1.1 Demonstrate command of the conventions of standard English grammar and usage when writing or speaking. (CCL2)

- a. Demonstrate legible cursive writing skills.
- b. Use relative pronouns (who, whose, whom, which, that) and relative adverbs (where, when, why).
- c. Form and use the progressive (e.g., I was walking; I am walking; I will be walking) verb tenses.
- d. Use modal auxiliaries (e.g., can, may, must) to convey various conditions.
- e. Order adjectives within sentences according to conventional patterns (e.g., a small red bag rather than a red small bag).
- f. Form and use prepositional phrases.
- g. Produce complete sentences, recognizing and correcting inappropriate fragments and run-ons.
- h. Correctly use frequently confused words (e.g., to, too, two; there, their).

- a. Use correct capitalization.
- b. Use commas and quotation marks to mark direct speech and quotations from a text.
- c. Use a comma before a coordinating conjunction in a compound sentence.
- d. Spell grade-appropriate words correctly, consulting references as needed.

- a. Choose words and phrases to convey ideas precisely.

Cluster 3: Vocabulary Acquisition and Use

- a. Use context (e.g., definitions, examples, or restatements in text) as a clue to the meaning of a word or phrase.
- b. Use common, grade-appropriate Greek and Latin affixes and roots as clues to the meaning of a word (e.g., *telegraph*, *photograph*, *autograph*).
- c. Consult reference materials (e.g. dictionaries, glossaries, thesauruses), both in print and digital, to find the pronunciation and determine or clarify the precise meaning of key words and phrases.

LAFS.4.L.3.5 Demonstrate understanding of figurative language, word relationships, and nuances in word meanings. (*CCL3*)

- a. Explain the meaning of simple similes and metaphors (e.g., as pretty as a picture) in context.
- b. Recognize and explain the meaning of common idioms, adages, and proverbs.
- c. Demonstrate understanding of words by relating them to their opposites (antonyms) and to words with similar but not identical meanings (synonyms).

LAFS.4.L.3.6 Acquire and use accurately general academic and domain-specific words and phrases as found in grade level appropriate texts, including those that signal precise actions, emotions, or states of being (e.g., *quizzed*, *whined*, *stammered*) and that are basic to a particular topic (e.g., *wildlife*, *conservation*, and *endangered* when discussing animal preservation.)
