## GENERAL NOTES

Laboratory investigations that include the use of scientific inquiry, research, measurement, problem solving, laboratory apparatus and technologies, experimental procedures, and safety procedures are an integral part of this course. The National Science Teachers Association (NSTA) recommends that at the high school level, all students should be in the science lab or field, collecting data every week. School laboratory investigations (labs) are defined by the National Research Council (NRC) as an experience in the laboratory, classroom, or the field that provides students with opportunities to interact directly with natural phenomena or with data collected by others using tools, materials, data collection techniques, and models (NRC, 2006, p. 3). Laboratory investigations in the high school classroom should help all students develop a growing understanding of the complexity and ambiguity of empirical work, as well as the skills to calibrate and troubleshoot equipment used to make observations. Learners should understand measurement error; and have the skills to aggregate, interpret, and present the resulting data (National Research Council, 2006, p.77; NSTA, 2007).

Instructional Practices:

Teaching from a range of complex text is optimized when teachers in all subject areas implement the following strategies on a routine basis:

1. Ensuring wide reading from complex text that varies in length.
2. Making close reading and rereading of texts central to lessons.
3. Emphasizing text-specific complex questions, and cognitively complex tasks, reinforce focus on the text and cultivate independence.
4. Emphasizing students supporting answers based upon evidence from the text.
5. Providing extensive research and writing opportunities (claims and evidence).

Recognize that the universe contains many billions of <u>galaxies</u>, and each <u>galaxy</u> contains many billions of stars. Describe and explain what characterizes science and its methods.

SC.912.N.1.2:

**Remarks/Examples:**

Science is characterized by empirical observations, testable questions, formation of hypotheses, and experimentation that results in stable and replicable results, logical reasoning, and coherent theoretical constructs.

Describe and provide examples of how similar investigations conducted in many parts of the world result in the same outcome.

**Remarks/Examples:**

Recognize that contributions to science can be made and have been made by people from all over the world.

Describe how scientific inferences are drawn from scientific observations and provide examples from the content being studied.

**Remarks/Examples:**

Collect data/evidence and use tables/graphs to draw conclusions and make inferences based on patterns or trends in the data.

Recognize the role of creativity in constructing scientific questions, methods and explanations.

**Remarks/Examples:**

Work through difficult problems using creativity, and critical and analytical thinking in problem solving (e.g. convergent versus divergent thinking and creativity in problem solving).

Identify which questions can be answered through science and which questions are outside the boundaries of scientific investigation, such as questions addressed by other ways of knowing, such as art, philosophy, and religion.

**Remarks/Examples:**

Identify scientific questions that can be disproved by experimentation/testing. Recognize that pseudoscience is a claim, belief, or practice which is presented as scientific, but does not adhere to strict standards of science (e.g. controlled variables, sample size, replicability, empirical and measurable evidence, and the concept of falsification).

Florida Standards Connections: MAFS.K12.MP.3: Construct viable arguments and critique the reasoning of others.

Explain that scientific knowledge is both durable and robust and open to change. Scientific knowledge can change because it is often examined and re-examined by new investigations and scientific argumentation. Because of these frequent examinations, scientific knowledge becomes stronger, leading to its durability.

**Remarks/Examples:**

Recognize that ideas with the most durable explanatory power become established theories, but scientific explanations are continually subjected to change in the face of new evidence.

Describe instances in which scientists' varied backgrounds, talents, interests, and goals influence the inferences and thus the explanations that they make about observations of natural phenomena and describe that competing interpretations (explanations) of scientists are a strength of science as they are a source of new, testable ideas that have the potential to add new evidence to support one or another of the explanations.

Recognize that scientific questions, observations, and conclusions may be influenced by the existing state of scientific knowledge, the social and cultural context of the researcher, and the observer's experiences and expectations. Identify possible bias in qualitative and quantitative data analysis.

Describe the role consensus plays in the historical development of a theory in any one of the disciplines of science.

**Remarks/Examples:**

Recognize that scientific argument, disagreement, discourse, and discussion create a broader and more accurate understanding of natural processes and events.

Explain that scientific laws are descriptions of specific relationships under given conditions in nature, but do not offer explanations for those relationships.

Recognize that a scientific theory provides a broad explanation of many observed phenomena while a scientific law describes how something behaves.

Recognize that theories do not become laws, nor do laws become theories; theories are well supported explanations and laws are well supported descriptions.

**Remarks/Examples:**

Recognize that theories do not become laws, theories explain laws. Recognize that not all scientific laws have accompanying explanatory theories.

Describe the function of models in science, and identify the wide range of models used in science.

<p><a href="#">SC.912.N.4.1:</a></p>	<p>Explain how scientific knowledge and reasoning provide an empirically-based perspective to inform society's decision making.</p> <p><b>Remarks/Examples:</b> Recognize that no single universal step-by-step scientific method captures the complexity of doing science. A number of shared values and perspectives characterize a scientific approach.</p> <p>MAFS.K12.MP.1: Make sense of problems and persevere in solving them, and MAFS.K12.MP.2: Reason abstractly and quantitatively.</p>
<p><a href="#">SC.912.P.8.1:</a></p>	<p>Differentiate among the four states of matter.</p> <p><b>Remarks/Examples:</b> Differentiate among the four states of <u>matter</u> (solid, <u>liquid</u>, <u>gas</u> and plasma) in terms of <u>energy</u>, particle <u>motion</u>, and phase transitions. (Note: Currently five states of <u>matter</u> have been identified.)</p>
<p><a href="#">SC.912.P.8.3:</a></p>	<p>Explore the scientific theory of atoms (also known as atomic theory) by describing changes in the atomic model over time and why those changes were necessitated by experimental evidence.</p> <p><b>Remarks/Examples:</b> Describe the development and historical importance of atomic theory from Dalton (atomic theory), Thomson (the electron), Rutherford (the <u>nucleus</u> and "gold foil" <u>experiment</u>), and Bohr (planetary <u>model</u> of <u>atom</u>), and understand how each discovery leads to modern atomic theory.</p> <p>Florida Standards Connections: MAFS.K12.MP.4: <u>Model</u> with mathematics.</p>
<p><a href="#">SC.912.P.10.1:</a></p>	<p>Differentiate among the various forms of energy and recognize that they can be transformed from one form to others.</p> <p><b>Remarks/Examples:</b> Differentiate between kinetic and potential <u>energy</u>. Recognize that <u>energy</u> cannot be created or destroyed, only transformed. Identify examples of transformation of <u>energy</u>: <u>Heat</u> to <u>light</u> in incandescent electric <u>light</u> bulbs <u>Light</u> to <u>heat</u> in laser drills Electrical to sound in radios Sound to electrical in microphones Electrical to chemical in battery rechargers Chemical to electrical in dry <u>cells</u> Mechanical to electrical in generators [power plants] Nuclear to <u>heat</u> in nuclear reactors Gravitational potential <u>energy</u> of a falling object is converted to <u>kinetic energy</u>, then to <u>heat</u> and sound <u>energy</u> when the object hits the ground.</p>
<p><a href="#">SC.912.P.10.2:</a></p>	<p>Explore the Law of Conservation of Energy by differentiating among open, closed, and isolated systems and explain that the total energy in an isolated system is a conserved quantity.</p> <p><b>Remarks/Examples:</b> Use calorimetry to illustrate conservation of <u>energy</u>. Differentiate between the different types of systems and solve problems involving conservation of <u>energy</u> in simple systems (Physics). Explain how conservation of <u>energy</u> is important in chemical reactions with bond formation and bond breaking (Chemistry).</p>
<p><a href="#">SC.912.P.10.3:</a></p>	<p>Compare and contrast work and power qualitatively and quantitatively.</p> <p><b>Remarks/Examples:</b> Describe both qualitatively and quantitatively how work can be expressed as a change in mechanical <u>energy</u>, and the concept of power as the rate at which work is done per unit time. Recognize that when a net <u>force</u>, F, acts through a distance on an object of <u>mass</u>, m, work is done on the object.</p>
<p><a href="#">SC.912.P.10.4:</a></p>	<p>Describe heat as the energy transferred by convection, conduction, and radiation, and explain the connection of heat to change in temperature or states of matter.</p> <p><b>Remarks/Examples:</b> Explain the mechanisms (<u>convection</u>, <u>conduction</u> and radiation) of <u>heat</u> transfer. Explain how <u>heat</u> is transferred (<u>energy in motion</u>) from a region of higher temperature to a region of lower temperature until equilibrium is established. Solve problems involving <u>heat</u> flow and temperature changes by using known values of specific <u>heat</u> and/or phase change constants (latent <u>heat</u>). Explain the phase transitions and temperature changes demonstrated by a heating or cooling curve.</p>
<p><a href="#">SC.912.P.10.5:</a></p>	<p>Relate temperature to the average molecular kinetic energy.</p> <p><b>Remarks/Examples:</b> Recognize that the internal energy of an object includes the energy of random <u>motion</u> of the object's <u>atoms</u> and <u>molecules</u>, often referred to as thermal energy.</p>
<p><a href="#">SC.912.P.10.10:</a></p>	<p>Compare the magnitude and range of the four fundamental forces (gravitational, electromagnetic, weak nuclear, strong nuclear).</p> <p><b>Remarks/Examples:</b> Recognize and discuss the effect of each <u>force</u> on the structure of <u>matter</u> and the evidence for it.</p>
<p><a href="#">SC.912.P.10.13:</a></p>	<p>Relate the configuration of static charges to the electric field, electric force, electric potential, and electric potential energy.</p> <p><b>Remarks/Examples:</b> Using Coulomb's <u>law</u>, determine the <u>force</u> on a stationary charge due to other stationary charges, and explain that this <u>force</u> is many times greater than the gravitational <u>force</u>. Recognize the relationship between <u>forces</u> and their associated potential energies and that the electric field is directly related to the rate of change of the electric potential from point to point in space.</p>
<p><a href="#">SC.912.P.10.14:</a></p>	<p>Differentiate among conductors, semiconductors, and insulators.</p> <p><b>Remarks/Examples:</b> Describe band structure, valence <u>electrons</u>, and how the charges flow or rearrange themselves between <u>conductors</u> and <u>insulators</u>.</p>
<p><a href="#">SC.912.P.10.15:</a></p>	<p>Investigate and explain the relationships among current, voltage, resistance, and power.</p> <p><b>Remarks/Examples:</b></p>

	Use Ohm's and Kirchhoff's <u>laws</u> to explain the relationships among <u>circuits</u> .
<a href="#">SC.912.P.10.18:</a>	Explore the theory of electromagnetism by comparing and contrasting the different parts of the electromagnetic spectrum in terms of wavelength, frequency, and energy, and relate them to phenomena and applications. <b>Remarks/Examples:</b> Describe the <u>electromagnetic spectrum</u> (i.e., radio waves, microwaves, <u>infrared</u> , <u>visible light</u> , <u>ultraviolet</u> , <u>X-rays</u> and gamma rays) in terms of <u>frequency</u> , <u>wavelength</u> and <u>energy</u> . Solve problems involving <u>wavelength</u> , <u>frequency</u> , and <u>energy</u> .
<a href="#">SC.912.P.10.20:</a>	Describe the measurable properties of waves and explain the relationships among them and how these properties change when the wave moves from one medium to another. <b>Remarks/Examples:</b> Describe the measurable properties of waves ( <u>velocity</u> , <u>frequency</u> , <u>wavelength</u> , amplitude, period, reflection and refraction) and explain the relationships among them. Recognize that the source of all waves is a <u>vibration</u> and waves carry <u>energy</u> from one place to another. Distinguish between transverse and longitudinal waves in mechanical media, such as springs and ropes, and on the earth (seismic waves). Describe sound as a longitudinal wave whose speed depends on the properties of the medium in which it propagates.
<a href="#">SC.912.P.10.21:</a>	Qualitatively describe the shift in frequency in sound or electromagnetic waves due to the relative motion of a source or a receiver. <b>Remarks/Examples:</b> Describe the apparent change in <u>frequency</u> of waves due to the <u>motion</u> of a source or a receiver (the Doppler effect).
<a href="#">SC.912.P.10.22:</a>	Construct ray diagrams and use thin lens and mirror equations to locate the images formed by lenses and mirrors. <b>Remarks/Examples:</b> Use examples such as converging/diverging lenses and convex/concave mirrors. Use a ray diagram to determine the approximate location and size of the image, and the mirror equation to obtain numerical information about image distance and image size.
<a href="#">SC.912.P.12.1:</a>	Distinguish between scalar and vector quantities and assess which should be used to describe an event. <b>Remarks/Examples:</b> Distinguish between vector quantities (e.g., displacement, <u>velocity</u> , <u>acceleration</u> , <u>force</u> , and linear <u>momentum</u> ) and scalar quantities (e.g., distance, speed, <u>energy</u> , <u>mass</u> , work).  MAFS.912.N-VM.1.3 (+) Solve problems involving <u>velocity</u> and other quantities that can be represented by vectors.
<a href="#">SC.912.P.12.2:</a>	Analyze the motion of an object in terms of its position, velocity, and acceleration (with respect to a frame of reference) as functions of time. <b>Remarks/Examples:</b> Solve problems involving distance, <u>velocity</u> , speed, and <u>acceleration</u> . Create and interpret graphs of 1-dimensional <u>motion</u> , such as position versus time, distance versus time, speed versus time, <u>velocity</u> versus time, and <u>acceleration</u> versus time where <u>acceleration</u> is constant. Florida Standards Connections: <a href="#">MAFS.912.N-VM.1.3</a> (+) Solve problems involving velocity and other quantities that can be represented by vectors.
<a href="#">SC.912.P.12.3:</a>	Interpret and apply Newton's three laws of motion. <b>Remarks/Examples:</b> Explain that when the net <u>force</u> on an object is zero, no <u>acceleration</u> occurs thus, a moving object continues to move at a constant speed in the same direction, or, if at rest, it remains at rest (Newton's first <u>law</u> ). Explain that when a net <u>force</u> is applied to an object its <u>motion</u> will change, or accelerate (according to Newton's second <u>law</u> , $F = ma$ ). Predict and explain how when one object exerts a <u>force</u> on a second object, the second object always exerts a <u>force</u> of equal magnitude but of opposite direction and <u>force</u> back on the first: $F_1 \text{ on } 2 = -F_1 \text{ on } 1$ (Newton's third <u>law</u> ).
<a href="#">SC.912.P.12.4:</a>	Describe how the gravitational force between two objects depends on their masses and the distance between them. <b>Remarks/Examples:</b> Describe Newton's <u>law</u> of universal gravitation in terms of the <u>attraction</u> between two objects, their masses, and the inverse square of the distance between them.
<a href="#">SC.912.P.12.5:</a>	Apply the law of conservation of linear momentum to interactions, such as collisions between objects. <b>Remarks/Examples:</b> (e.g. elastic and completely inelastic collisions).
<a href="#">SC.912.P.12.7:</a>	Recognize that nothing travels faster than the speed of light in vacuum which is the same for all observers no matter how they or the light source are moving. <b>Remarks/Examples:</b> Recognize that regardless of the speed of an observer or source, in a <u>vacuum</u> the speed of <u>light</u> is always $c$ .
