NEW 40 point Reading Renewal Requirement



WHO NEEDS TO DO THIS (Certificates expiring 6/30/2025 and after)

The requirement applies to anyone with the following Certification coverages regardless of job title:

- Elementary Education (K-6)
- Prekindergarten/Primary Education (age 3 through gr. 3)
- Elementary Education (grades 1-6)
- Primary Education (grades K-3)
- English (grades 1-6)
- Middle Grades English (grades 5-9)
- Middle Grades Integrated Curriculum (grades 5-9)
- English (6-12)
- Reading (K-12)
- Reading (Endorsement)
- English for Speakers of Other Languages (ESOL K-12)
- NOT REQUIRED FOR ESOL ENDORSEMENT
- Exceptional Student Education (K-12)



COURSE REQUIREMENTS

- In the use of explicit, systematic, and sequential approaches to reading instruction, developing phonemic awareness, and implementing multisensory intervention strategies
- Approval of coursework is at the discretion of districts within their professional learning catalog.
- A total of 40 points is required (some courses do not total 40, but can be used towards the total of the 40 points)
- Some courses satisfy the 20 point SWD requirement and counts towards the 40 points required for reading.
- This requirement **must** be satisfied for **every** renewal starting with 6/30/2025 and after.
- Failure to earn the 40 points required for reading will result in the certification coverage being deleted from your certificate or it could prevent your professional certificate from being renewed.

- Approved Courses in eLM. You can find them by going to the District Portal, the click on the PeopleSoft tile > MyLearning >in the Search bar type **"Reading Renewal"** (ex. PDA courses)
- www.BeaconEducator.com - Read course/module description - it must state that the course meets requirement for HB 7069 (Reading instruction). Submit the certificate of completion with renewal documents.
- If you have taken a reading college course(s) that you think may satisfy this requirement please send the unofficial transcript and a course syllabus via email to Maryann.Colbert@palmbeachschools.org for confirmation of eligibility.
 - Once the course has been vetted by the Reading Team go to District Portal, the click on the PeopleSoft tile > MyLearning >in the Search bar type "Certification Upload" and you will need to upload the email vetting the course and the unofficial transcripts.
- The Reading Renewal points must be earned during current validity period (ex. 7/1/2020-6/30/2025) or within the previous validity period (7/1/2015-6/30/2020).
