**RATING**

\_\_\_\_\_ **Satisfactory:** The processes are generally effective (1) **no more than three** indicators are rated non-complaint, (2) **none** of the indicators are material repeat findings, and (3) the school is not in a deteriorating financial condition or there are no issues of material non-compliance identified by the district.

**\*NOTES:**

**Maintains positive financial trends** – The financial indicators appear to show negative trends, on contrast to positive trends seen over the previous fiscal years. Net Assets have fallen into a deficit. Unrestricted days of cash is roughly 2.5, which is below the recommended minimum of 30 days. This may indicate that the school is not retaining enough unrestricted cash to meet cash obligations. Debt to Asset ratio also shows a steady increase over the past fiscal years. General Fund balance remains in a deficit during FY2020. Other financial indicators provided below show decreases as well. (*Repeat Concern*)

**Maintain adequate fund balance** – As with the note regarding positive financial trends, the General Fund continues with a deficit balance. Additionally, unrestricted General Fund balance compared to General Fund operating revenues was roughly (**4%**), well below the recommended minimum of 3%. This may indicate the school is not retaining adequate fund balance to withstand financial emergencies. (*Repeat Concern*)

**Maintained steady FTE counts** – The school has shown a steady decline in FTE over the previous five fiscal years. Enrollment is the main source of revenue for the charter school, this may lead to issues in the future if enrollment is not increased and/or maintained. (*Repeat Concern*)

**COVID-19** - In March 2020, the World Health Organization declared the outbreak of a coronavirus (COVID 19) a pandemic. As a result, the local and global financial markets are experiencing significant declines and creating economic uncertainties. At this time, it is unknown precisely how this negative outlook will impact the School's financial statements in the future.
